FRASER RIVER ENVIRONMENTAL EFFECTS MONITORING (EEM)

For over 15 years, Hatfield has implemented the Federal EEM program for pulp and paper mill clients in the upper Fraser River watershed. The program provides a collaborative regional approach to assessing potential environmental effects from pulp-mill discharges into the Fraser River and is designed to achieve national uniformity in monitoring effects, while taking into consideration site-specific factors.



COASTAL DIOXIN/FURAN MONITORING PROGRAMS

Hatfield has conducted annual dioxin and furan trend-monitoring programs for the pulp and paper industry in British Columbia for over 20 years. Trends in the concentration of dioxins and furans in biological tissues and sediments were associated with changes in effluent treatment and the bleaching process. These programs are among the most comprehensive, long-term dioxin-monitoring initiatives ever undertaken.



ENVIRONMENTAL MONITORING AT A PULP MILL IN INDONESIA

PT Hatfield Indonesia has monitored the environmental performance of a pulp mill in Sumatra for over 10 years. Hatfield is responsible for preparing monthly and semi-annual reports for submission to the Government of Indonesia and local authorities. The mill has been awarded "PROPER Green" status by the government, the highest level of environmental performance yet achieved by industrial operations in Indonesia.
