MONITORING AQUATIC ENVIRONMENTS IN THE OIL SANDS REGION

Hatfield has made a significant corporate commitment to environmental management within the oil sands region. Our team has carried out over 60 environmental projects for the oil sands industry in Alberta, including environmental impact assessments for proposed developments, environmental monitoring of aquatic environments, GIS and remote-sensing applications for development and reclamation activities, and environmental data management. ENVIRONMENTAL IMPACT ASSESSMENT OF A NATURAL GAS PIPELINE

Hatfield reviewed and evaluated the marine component of the environmental impact assessment (EIA) documentation submitted to the National Energy Board in support of the Georgia Strait Crossing Project, a proposed submarine natural gas pipeline crossing from Washington State to Vancouver Island. We provided the National Energy Board with time-sensitive information regarding potential environmental impacts and environmental management issues during the Joint Review Panel process and associated hearings. Hatfield also prepared the Marine Environment section of the Joint Review Panel Report.



ENVIRONMENTAL RISK ASSESSMENT AND ENVIRONMENTAL MONITORING SURVEY

Hatfield is conducting an environmental risk assessment (ERA) and Environmental Monitoring Survey for TOTAL E&P Indonesia in the Mahakam Delta, East Kalimantan, Indonesia. The project will investigate the fate and behaviour of produced water constituents from a central processing unit outlet to the Mahakam River, and to determine if the discharge of constituents is effecting the aquatic environment. The Environmental Monitoring Survey of the Mahakam Delta and offshore fields is designed to determine the effects from historical and current drilling discharge activities. The sampling encompasses water and sediment chemistry, benthos, and socio-economic data.
